Legal Reserve

For properties with a legal reserve deficit, we offer compensation through the lease of land, in São Paulo, Goiás, Federal District and Mato Grosso do Sul, backed by the security of those who have been managing for more than 100 years.

Nature-based Consulting Solutions or Multiple Use of Land

Through our expertise in green economy business development we analyze the potential strengths of land in different biomes and propose a sustainable use model that combines land conservation with economic activities, generating revenue and a positive reputatio.

Pioneering in the carbon market

We implemented the first REDD+ project in the Brazilian Cerrado and launched an unprecedented methodology for generating carbon credits by Payment for Ecosystem Services (PES) in the Atlantic Forest.



Carbon credit

Project development and sales

We generate carbon credits from preserved forests or planting of new forest areas.

We develop studies and work on projects and methodologies to identify and value the carbon stock and sequestration potential of forests, providing a viable alternative for the conservation of sociobiodiversity.



Conserved forest

We have been pioneers in applying and proposing methods for generating carbon credits, initially on the areas managed by Reservas Votorantim, and are now making these available to other landowners through consultancy.

Restauration

Through insetting solutions, we help companies to include tree planting in their corporate strategies as a way of sequestering carbon and include this as a discount factor in their emissions inventories.

Credit Management

We create opportunities to generate credits, manage long-term contracts and develop strategies to take advantage of the best conditions in the carbon market.

Biodiversity Centers

In the areas we manage, we develop spaces that combine scientific research with the production of native flora, from the Atlantic Forest and the Cerrado for landscaping and ecological restoration projects.

Ecological restoration

We offer a variety of solutions that provide all the support and operational capacity to carry out restoration projects across the country, extending beyond the regions where we operate our Biodiversity Centers.

Biotechnology

Through scientific research combined with biotechnology, we have identified the forest's potential for generating active ingredients to be used as bioproducts such as medicines, fragrances and flavors for the cosmetics and food industries.
